

COMPETITION TERMS AND CONDITIONS

'LA TROBE FINANCIAL – COLLINGWOOD & PRESIDENTS FUNCTION COMPETITION'

1. This document contains the terms and conditions of entry ("these terms") into the 'Collingwood and MCC Committee Function competition' ("Promotion"), information on how to enter the Promotion, and information about the prizes which form part of these terms. Entry into this Promotion is deemed acceptance of these terms. By entering this Promotion, the Entrant acknowledges that they have read, understood and agree to be bound by and abide by these terms.
2. The promoter is Collingwood Football Club Limited (ABN 89 006 211 196) of KGM Centre, Cnr Olympic Blvd and Batman Ave, Melbourne VIC 3000 ("Promoter").
3. The Promoter is an official partner of La Trobe Financial Services Pty Limited ACN 006 479 527 of Level 25, 333 Collins Street, Melbourne, Victoria (La Trobe Financial).
4. Subject to the Australian Consumer Law, the Promoter may vary the terms of, or terminate, this Promotion at any time at its absolute discretion without liability to any Entrant or other person. The Promoter will not award any prize if the Promotion is terminated for whatever reason. If the Promotion is not capable of being conducted due to circumstances beyond the Promoter's control, including due to any technical or communications problems, the Promoter reserves the right to amend, suspend or cancel the Promotion.
5. The Promotion does not require a permit.

DEFINITIONS

6. In these terms, the following meanings apply in addition to terms which are defined elsewhere in these terms unless the contrary intention appears:
 - "Eligible Entrant" means a person who is eligible to participate in the promotion in accordance with clause 7 of these terms.
 - "Entrant" refers to an Eligible Entrant who has entered the Promotion.
 - "Prize" has the meaning in clause 12.
 - "Winner" means the Entrant whose name is randomly drawn from all Entrants during a Promotional Period.

PROMOTION PERIOD

7. The Promotional Period will be open from 9.00am Australian Eastern Standard Time ("AEST") on Monday 6th July, 2026 and will continue until 8.00pm (AEST) Saturday 18th July, 2026 ("Promotion Period").

ELIGIBILITY

8. To be eligible to enter the competition you must:

- Reside in Australia; and
- be 18 years or older

Eligible Entrants exclude employees of the Promoter and other agencies, firms or companies associated with the Promotion, and their immediate

families. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or first cousin.

HOW TO PARTICIPATE

9. Have 1 x President Function ticket to the Round 19 v Carlton, Saturday 18th July 2026
10. To participate in the Promotion and be eligible to win, an Eligible Entrant must complete their details into the entry form. Incomplete entries or entries not meeting the guidelines will be deemed invalid and not be entered into the draw.
11. One (1) Winner will be chosen at random at the Presidents Round 19 function at 8:30 PM AEST on Saturday 18th July 2026, following the Promotional Period. LIMITS OF ENTRY

13. Any such use by, or on behalf of, the Promoter may occur without acknowledgment, remuneration or compensation to the Winner. Limit of one entry per person.

PRIZES AND PRIZE RESTRICTIONS

15. After the Prize Winner is selected in accordance with these Terms, the Prize Winner must:
 - a. read and agree to the terms of the Credit Fund's Product Disclosure Statement (PDS) and should consider the Target Market Determination on La Trobe Financial's [website](#) to assist with deciding whether the investment in the 12 Month Term Account is suitable for their needs and circumstances; and
 - b. if they decide to accept the Prize, the Winner must, within seven (7) days, email a certified copy of either a current valid passport or a current valid driver's licence as proof of identity, address and age. General
